



necessary to ensure that further improper action to remove Mr. DeLay from the ballot and have him replaced with another candidate does not occur. Plaintiffs have no adequate remedy at law because the damages from Defendant's anticipated unlawful conduct are incalculable and could not serve as adequate compensation for the wrong inflicted on Plaintiffs and the voters of the state.

THEREFORE, the Court:

ORDERS that Tina J. Benkiser, in her capacity as Chairwoman of the Republican Party of Texas, or anyone acting on her behalf or at her direction, is enjoined from calling a District Executive Committee formed in relation to the election race for District 22 of the United States House of Representatives. Furthermore, Tina J. Benkiser, in her capacity as Chairwoman of the Republican Party of Texas, or anyone acting on her behalf or at her direction, is enjoined from taking any measures to replace Thomas D. DeLay as the Republican Party nominee for District 22 of the United States House of Representatives. It is further

ORDERED that Tina J. Benkiser, in her capacity as Chairwoman of the Republican Party of Texas, is enjoined from proposing and/or certifying any candidate other than Thomas D. DeLay to appear on the ballot in the 2006 General Election as Republican Party nominee for District 22 of the United States House of Representatives.
